

## “WHAT NEXT” PROJECT | OPEN CALL FOR WORKS

### Rules and Regulations

#### § 1

##### General stipulations

1. The open call is organised by:  
**The Adam Mickiewicz Institute**, seated in Warsaw (00-560), 25 Mokotowska Street, a national culture institution listed in the Register of Culture Institutions, created by the Ministry of Culture and National Heritage under the following number: RIK 70/2006, phone +48 (22) 44 76 100, fax +48 (22) 44 76 152 (“AMI”).
2. The open call for works shall proceed according to the present Rules and Regulations as well as the general laws in force.
3. The objective of the call is to select works to be displayed as a part of the “What Next” exhibition (“Exhibition”). The Exhibition will be presented within the area of The Republic of Poland as well as other countries in 2021 and 2022.
4. The works presented in the Exhibition will be selected by the curators of the Exhibition in the accordance with the Exhibition's concept created by them.

#### § 2

##### The subject of the open call and conditions of participation

1. The open call is directed to the citizens of Poland, Ukraine and United Kingdom.
2. The minimum age of participation is 18.
3. The participants shall apply individually or in a collective.
4. The open call has one stage.
5. The AMI is entitled cancel the open call without providing a reason.

#### § 3

##### How and when to apply

1. The receipt of applications will comprise:
  - a. A duly filled out application which constitutes an Appendix 1 of these Regulations;
  - b. Documentation or visualization of the submitted project;
  - c. A portfolio consisting of a PDF file of 10 pages at the maximum.
2. Participants can submit more than one project.
3. The applications can be submitted from **15 July 2020 until 24 September 2020 11:59 pm CET** to the following e-mail address: [opencall@iam.pl](mailto:opencall@iam.pl), with “**What Next 2020**” in the subject line.
4. Applications sent after the date stipulated above shall not be accepted.
5. AMI reserves the right to contact the participant should any questions arise.
6. The applications shall be submitted in **English**. Applications submitted in other languages will not be taken into consideration.
7. The application should be submitted by filling in the application form, included as Appendix no. 1 to the present Rules and Regulations.

8. Should the application not fulfil the formal requirements stipulated in the Rules and Regulations, it will be rejected.

#### **§ 4**

##### **The results of the open call**

1. The professional Commission can select unlimited number of works.
2. The Commission shall be appointed by AMI and will be announced on AMI's website.
3. The artists shall be selected on the basis of the artistic value of the submitted projects.
4. AMI hereby reserves the right to select less participants by the decision of the Commission or not to select any participants, should the applications submitted not correspond with the initial Concept and purposes of AMI.
5. The Commission's decision is final and cannot be appealed against.

#### **§ 5**

##### **The information about the results of the competition**

1. The participants shall be informed about the results of the Open Call via e-mail not later than 15 October 2020.
2. AMI is entitled to publish the name, surname and selected information concerning artistic activity of selected participants as well as to include this information in order to inform about and promote the open call and the project, according to the scope of statutory activity of the AMI.

#### **§ 6**

##### **Providing explanation concerning the regulations**

Each participant is entitled to request an explanation of the contents of the following Rules and Regulations from the AMI. The questions should be directed via e-mail to [opencall@iam.pl](mailto:opencall@iam.pl). AMI will provide explanation within 4 working days from the moment of receiving the question.

#### **§ 7**

##### **Information concerning the data processing**

According to Article 13 from the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (GDPR), Adam Mickiewicz Institute hereby informs:

1. The administrator of personal data is the Adam Mickiewicz Institute seated in Warsaw (00-560), at Mokotowska 25 St., included in the Register of Culture Institutions created by the Ministry of Culture and National Heritage, under no. RIK 79/2006.

3. The personal data of the participant will be processed on the basis of:
  - a. Art. 6 act 1 let. f GDPR - legal basis of IAM interests, such as purposes related to Organising the open call, selecting candidates and providing support as well as in order to inform about the participants and promote as well as provide information about the call.
4. Personal information will be processed till the end of the open call, and in case of the selected participants, until the exhibition is no longer available.
5. After data processing stops, personal data will be stored as a result of the legal obligation to retain data for the period resulting from the Act of 14 July 1983 on the National Archives and

the regulations that were stipulated in Adam Mickiewicz Institute on the basis of the act mentioned above.

6. The controller of the participants' personal data will be the service providers of systems and software utilised at the Adam Mickiewicz Institute, external providers that provide services for Adam Mickiewicz Institute.
7. The data shall not be transferred to a third country nor international organisation.
8. The person that the data concerned is entitled to control the processing of their data as stipulated in Art. 15-16 GDPR, specifically the right to access to the content of data and the right to correct it, as well as GDPR Art. 17 and 18 - right to remove data and restrict data processing if applicable.
9. Personal data will not be processed in an automated manner, which would affect making decisions that could have legal implications or a similar affect. The data will not be profiled.
10. The participant is entitled to submit a complaint against the supervising organ to the following address:

## **§ 8**

### **Final stipulations**

1. In points of dispute the Commission shall have the final say.
2. To all matters not settled herein, corresponding provisions of the Polish law shall apply.
3. The regulations may change and in case of such, the changes to the regulations shall be published in the same way in which the regulations were published, as well as sent to the participants that applied before the day on which the regulations were changed.
